OILD Debrief – Lynn I reported that while Silver Falls is a nice location, it's expensive which attributed to the budget deficit. Cherie distributed the OILD financials. Discussion occurred on the high alcohol charges and registration amounts. Lynn I clarified that the charge was an error. Registration may increase from \$450 to \$550/person. More discussion to follow.

<u>National Fall Conference Update</u> – Lynn I and Cherie reported that everything was pretty much done. Proposals are coming in. Constant Contact will be used for registration, but not for emails. Heather will create the reg page.

<u>National Membership</u> – Oregon's Chapter pays National \$10/person for anyone attending OILD or Summer or Fall conferences for any school that doesn't already pay an institutional membership directly to National.

<u>Financials</u> – Cherie distributed copies of the Chapter's financials (as of July 1, 2016), which included the final OILD accounting. Anticipated profit for OILD was \$1,590, but it ended up with a \$2,063.22 deficit. Also reviewed was the Proposed 2016-17 Budget.

Checking \$8,158.20 MM Savings \$8,287.45 CD \$20,518.21 TOTAL \$36,963.86

Donna Z's motion to *approve the 2016-17 Budget, as presented*, was seconded by Lynn N. Upon call for the vote, the *MOTION PASSED* unanimously.

Discussion occurred on the CD and leaving it in whole @ 2.75% interest or taking \$10,000 out and keeping the remainder in a CD. Cherie also shared that she discovered that Square was not cost effective for our use. The Key Bank would not let us link it to our account without hefty fees. We are looking into Constant Contact or taking cash/checks for Silent Auction items.

<u>Chapter Development Board Travel</u> – A brief discussion occurred on the use of funds for Board members to travel to chapters to help with development.
